Kadena Officers' Spouses' Club Constitution Article 9 / Dissolution

In case of dissolution of the organization, whatever funds are contained in the treasury at the time will be used to satisfy any outstanding debts, liabilities, or obligations. The remaining of the assets will be disposed IAW 34-223/18 WG Sup.1 paragraph 12, by donating to a charitable institution decided upon the majority vote of the members. In the event the association is dissolved and liabilities exceed assets, all members equally assume the liabilities to the extent recognized by law. Each prospective member will be informed that they may become personally liable, to the extent recognized by law, for the debts of the association. Should KOSC decide to disband or shutdown IAW AFI 34-223, its officers will notify the Force Support Squadron Commander or Division Chief of their intent to dissolve the private organization and will prepare a time phased action to do so.
